Rental Contract

1. Renter acknowledges that, prior to taking possession of the instrument herein described, the instrument is in good playing condition and in good repair.
2. The term and start date covered by this contract are noted on the payment information sheet. At the end of the term, the instrument must either be returned, or the contract will be automatically extended for three (3) months increments until the instrument is returned. If the instrument is not returned at the end of the rental period, the full retail value will be charged to the renter.
3. Renter must provide a valid credit card. The first three (3) months rental fees are due before receipt of instrument; these fees are non-refundable. Rental fees are due in advance, and will be charged every three months during the term of this contract to the Renter's credit card. All unpaid fees are due at the time of return.
4. If the instrument is returned at any time before the end of the contract term, fees will be prorated at the full rental rate (not the discounted rate associated with the contract term) plus a restocking fee equal to one (1) months' rent. Renter also agrees to pay all freight charges related to receipt and return of the instrument.
5. The instrument will be returned to **Regh Violins**, 36 Sherwood Heights, Wappingers Falls, NY 12590, or at a place and time mutually agreeable at the termination of the rental period.
6. Rental instruments may be purchased, and some percentage of rental fees can be applied towards purchase. Rental Credit will accrue at 100% for the first two years of rental, and 20% in year three. Payments received after year three do not apply to Rental Credit. Rental Credit may be applied towards 50% of the purchase price of any instrument or outfit (instrument, bow, case) from **Regh Violins**. Rental Credit must be applied to purchase within 30 days of return of the rental instrument or the expiration date of the contract.
7. Instrument is insured against damage caused by normal wear and tear by **Regh Violins**. **Regh Violins** must perform all repairs and adjustments on rental instruments, bows and cases. Repairs or adjustments performed by renter or by any shop or person other than **Regh Violins** may result in a charge of up to the full retail price of the instrument, bow or case. **Regh Violins** will not compensate customers for repairs or adjustments done elsewhere. Broken strings, bridge replacement and bow rehair are not covered and are the responsibility of renter. Damage insurance may be purchased at an additional fee. Theft is not covered by insurance.
8. If the instrument is lost, stolen, or is badly damaged from abuse, the renter assumes responsibility for the full retail value of the instrument. **Regh Violins** is the sole determiner of abuse or neglect, and its determinations are final. In the event of repairable damage, renter is responsible for the cost of the repair and any resulting devaluation of the instrument.
9. Upon failure to comply with the above conditions, **Regh Violins** reserves the right to terminate this agreement without notice and repossess the instrument.
10. If it becomes necessary to employ council to collect the obligation and/or repossess the instrument described herein, the renter hereby agrees to pay any and all reasonable attorney fees for the services of such council together with all other costs and disbursements in connection therewith whether or not suit be brought.
